		2. As per Drugs and Cosmetics Act, 1940, New Drugs shall be approved by CDSCO. Please note that CDSCO have approved Triclosan coated Sutures in 2004 for import into India and based on the same approval, J&J has been given manufacturing licence in 2005 by Drugs Controller for the State of Maharashtra. Based on the same principle, we were given manufacturing licence in 2012 for Triclosan coated Sutures by Drugs Controller for the State of Karnataka. We continue to hold the valid manufacturing licence.		Execute as per the rate contact agreement dt 22.1.2020
		3. A New Drug cease to be a New Drug after 3 years of first manufacturing in the Country. Therefore, approval of CDSCO is not required since the same product is no more a New Product under the Drugs and Cosmetics Act. Based on this Rule, there are other companies listed below are also manufacturing Triclosan coated sutures, based on the licence issued by State Drug Control Departments situated in various parts of the Country:

		Some of above manufacturers' licences issued by State Drugs Departments have expired and renewed by CDSCO as per Medical Devices Rules 2017/2018 on routine basis. This shows clearly that Triclosan coated suture is not a New Product any more.		
		4. Our company's manufacturing licence issued by State Drug Controller is valid up to 22-7-2022 and there is no Rule that we shall obtain fresh approval from CDSCO until the expiry of our licence. This condition is clearly stated in Medical Devices rules. Therefore, we have not approached CDSCO for any approval for Triclosan Coated Sutures. Insisting on CDSCO approval is not relevant now and insisting on this condition will go against genuine manufacturers who are following the Rules of the country sincerely. This is a transition stage where many Suture manufacturing companies are governed under CDSCO as well as State Drug Control authorities.		
		Insisting on CDSCO approval will amount to discrimination in favour few companies without any legal sanctity.		
		6. In fact, we request you to see the background under which Memo No.426212/H2/2016 dated 1-02-2017 issued by the Principal Secretary to Government and circumstances have changed thereafter. Reason for issue of this Memo is explained below:		
		a. The Memo was issued based on the CDSCO letter dated 30 th July 2013 file no. CLAA/MD/KR/03/2010-DC [copy enclosed]. As per this CDSCO letter, State Drug licensing Authorities have been instructed that Antibacterial Absorbable Surgical suture coated with chlorohexidine Diacetate 0.02% is a New Drug and further directed manufacturers to obtain new drug permission from CDSCO. Please note that this CDSCO circular is not for Trichlosan coated antibacterial sutures, but applicable only Antibacterial Absorbable Surgical suture coated with chlorohexidine Diacetate 0.02%.		
		b. There is no circular stating that Triclosan Coated is a New Drug as per CDSCO. This is supported with various licences issued by CDSCO as well as State Drug Controllers.		
		c. But in Tender no-61 [20-21] dated 3-6-2020, Eligibility criteria 2.A has asked all Anti Bacterial(Coated)Absorbable sutures to get CDSCO approval instead of asking only Chlorohexidine Diacetate coated Anti bacterial sutures to get CDSCO approval.		
		7. Further we are supplying our antibacterial sutures to various state corporations which includes RMSCL-Rajasthan Govt and TNMSC-Tamilnadu Govt, KDLWS-Karnataka Govt, Municipal Corporation of Greater Mumbai and Chhattisgarh Medical Corporation etc since 2015-16 and none of these State Government agencies asked for approval of CDSCO for Triclosan coated Antibacterial sutures.
