In the G.O 1st read above, Government have issued the New Procurement Policy of Andhra Pradesh (2009) including the procedure to be adopted to make available essential medicines of good quality, at all health facilities in the State at all times, procured at competitive prices in a transparent manner and to promote rational use of medicines.

2. In the G.Os 2nd to 5th read above, subsequent orders were issued approving the list of Essential Medicine List and Additional medicine list from time to time for the Years 2010, 2013,2015 and 2018.

3. In the G.O 7th and 8th read above, Government have issued orders for approving the List of Essential Medicines consisting of 477 Nos of Drugs & Medicines and List of Additional Medicines consisting of 130 Nos. of Drugs & Medicines for the year 2019.

4. In the reference 9th read above, the Director of Medical Education, AP has requested for approval of list of proposed Essential Medicines List (EML) containing 424 nos from the existing list and proposed Additional Medicines list (AML) consisting of No's.119 from the existing list and list of proposed new drugs in EML list containing 136 Nos and proposed new drugs for AML list containing 33 Nos, recommended by the Standing Expert Committee of EML & AML chaired by the Director of Medical Education and is as follows:
